#### Provenance and Historical Context

- 1. How does the painting's provenance, from Louis Roy to Sacha Guitry to the McKees, reflect broader themes of art's journey through private collections and the market?
- 2. What role does the absence of complete provenance play in shaping our understanding of *Flowers and Fruit's* authenticity?
- 3. How does the author use the history of auctions and art dealers to illustrate the relationship between art and commerce?
- 4. What social, economic, or cultural forces influenced *Flowers and Fruit's* transition from a private collection to the Haggin Museum?

#### Authenticity and Attribution

- 5. As explored in the book, what are the strengths and limitations of the three tools for authenticating art provenance, connoisseurship, and scientific analysis?
- 6. How does the story of the Greenhalgh family's forgery operation illuminate the vulnerabilities of the art world?
- 7. What does the discovery of Louis Roy's stamp on the back of *Flowers and Fruit* contribute to its authentication?
- 8. In what ways does the uncertainty surrounding *Flowers and Fruit* challenge traditional definitions of what constitutes an "authentic" work of art?

#### Gauguin's Life and Work

- 9. How does Paul Gauguin's background and artistic career shape the interpretation of works attributed to him?
- 10. What does the painting's inscription to Louis Roy suggest about Gauguin's relationships with his contemporaries and collaborators?
- 11. How does the cultural context of Gauguin's time (such as the Post-Impressionist movement) frame the analysis of *Flowers and Fruit*?

## Art Market Dynamics

- 12. What does the book reveal about the art market's role in creating and perpetuating an artist's legacy?
- 13. How did figures like Etienne Bignou and Sacha Guitry use their networks to influence the perceived value and circulation of Gauguin's works?
- 14. What role does celebrity play in the art market, as demonstrated by Sacha Guitry's purchase and promotion of *Flowers and Fruit*?
